During three decades of private practice, during which he worked Monday, Tuesday, Thursday, Friday and Saturday and devoted Wednesday mornings to teaching in the Periodontics Clinic at Case, Dr. Bob Skillicorn looked forward to time off. Now, having taken life easy since retiring in 2004, he looks forward to coming to work in the morning.

"At a perio meeting a year after retirement, Dr. Bissada asked me if I'd like to get back into teaching," says Dr. Skillicorn, who started back at the Dental School one day a week in January and has committed to four days a week beginning this summer. "Before retirement I *kind of* liked teaching, now I *really* like it."

Dr. Skillicorn, who thoroughly enjoys working with predoctoral dental students, finds that "great colleagues and responsible residents create a great working and teaching environment" at the Dental School. "But mostly it's the students themselves who make teaching fun," he adds. "They are knowledgeable, enthused about learning, and have a good attitude."

Dr. Skillicorn relishes teaching students a problem-solving approach to dentistry. When he consults with students on a case, he takes them on a "journey" of discovery, starting with the current complaint, going back through a patient's history, then moving on to diagnosis and prognosis to develop an action plan.

Torie Cox, a third-year dental student who plans to practice General Dentistry, was impressed with Dr. Skillicorn's enthusiasm for his students' learning. "Dr. Skillicorn truly has our best interests at heart," she says. "He is always willing to impart some knowledge and provoke interest in periodontics, so much so that he has given up his lunch hour on numerous occasions to help students with their scaling and probing techniques, review bone loss on radiographs, and calculate clinical attachment loss."

In perhaps the highest compliment a student can pay a teacher, Ms. Cox adds that she hopes one day to follow in her mentor's footsteps. "I'd like to help instruct and mold future dental clinicians," she says. "I would like to inspire others as Dr. Skillicorn has inspired me."

Dr. Bissada, Chair of the Periodontics Department, is thrilled to have someone with Dr. Skillicorn's expertise and experience make a commitment to full-time teaching. "Because of the big gap financially between private practice and education, there is a shortage of periodontists who are willing to spend the time to be teachers to the next generation," Dr. Bissada explains.


